BOARD OF SUPERVISORS  
MONTHLY MEETING  
October 1, 2018

The supervisors of Hickory Township met at the township building for their regular monthly meeting. The meeting was called to order at 7:00 pm with the Pledge of Allegiance. Supervisors present were Kathy Abranovich, and Mike Hall and Bill Dean. Also in attendance were Lisa Schlemmer , Larry Dillow, Thomas McCormick, Sr., Tom McCormick, Jr., Neal Miller, Phineas J. Minutes from the September 4, 2018 regular meeting were accepted as read without additions or corrections.

Minutes from the September 25, 2018 Budget Workshop Meeting were read and amended as follows:

Treasurer's report for the month of September was given. Motion made by Kathy, 2<sup>nd</sup> by Bill to pay current bills, payroll and all incoming regular bills, motion carried.

The police report was given for the month of July by Lieutenant Chad Adams: 183 total incidents. Due to the scheduling changes, Officer Joe Sager will have very little, if any, time available to work as a School Resource Office. Three (3) applications for the School Resource Officer position were received. The most qualified candidate was identified as Danielle Moffatt. A motion was made by Kathy, 2<sup>nd</sup> by Bill to give Chief Cook permission to hire Danielle Moffatt as a School Resource Officer.

The ordinance for the VFD Fire Tax Credit has been finalized and will be advertised for vote at the November meeting.

Kathy reported that Lawrence County Tourism requested a minimum donation of \$247.00 from the Township. This issue died due to lack of support or comment.

Bill confirmed the road closure of Eastbrook-Neshannock Falls Road through Briar Hill Road was to begin October 2, 2018 and briefly mentioned the detoured area for said closure.

Mike reports that the roadside grass cutting was recently completed. Jodi Johnson wished to express her gratitude for the grass cutting and that she was pleased with the job that was done in this regard.

A motion was made by Kathy, 2<sup>nd</sup> by Mike to adjourn the meeting at 7:24 PM. The motion carried.
